

SERIAL BOX PUBLISHING REMADE SEASON 2 SWEEPSTAKES OFFICIAL RULES

1. WHO IS ELIGIBLE

To register for SERIAL BOX PUBLISHING's **ReMade Season 2** Sweepstakes ("Sweepstakes"), participants must be at least 18, be a legal resident of the United States or the District of Columbia and must follow the entry requirements in the "How to Enter" Section below. Your participation in the Sweepstakes constitutes your agreement to be bound by these official rules ("Official Rules"). Void where prohibited by law. Employees, officers, directors, agents, and representatives of Serial Box Publishing ("SERIAL BOX PUBLISHING") its affiliates and subsidiaries, and their immediate family and household members, are not eligible to enter or to win. Employees, officers, directors, agents, and representatives of the United States federal government, and their immediate family and household members, are not eligible to enter or to win. Sweepstakes entrants are referred to as "you" or participant".

False and/or deceptive entries or acts shall render participants ineligible.

2. HOW TO ENTER

a) **No purchase necessary. The time period for completing the above where indicated is from Monday, October 23, 2017 12:00 p.m. EST and ends at Sunday, October 29, 2017 11:59 p.m. EST ("Sweepstakes Period"). Entries must be initiated during the Sweepstakes Period.

Alternatively, if you do not wish to subscribe to SERIAL BOX' Newsletter on the provided form within the Blog post announcing the Sweepstakes, send an email to info@serialbox.com with your name stating that you are entering SERIAL BOX PUBLISHING's ReMade Season 2 Sweepstakes. Such email must be received by SERIAL BOX PUBLISHING by the end of the Sweepstakes Period and SERIAL BOX PUBLISHING will time stamp when SERIAL BOX PUBLISHING receives the email.

b) There is a limitation of one entry per person during the Sweepstakes Period.

3. DETERMINATION OF WINNER

There will be five winners for the Sweepstakes. Odds of winning depend on the number of eligible entries received. SERIAL BOX PUBLISHING will select the winners at random.

4. PRIZES

a) The prize for the winners of the Sweepstakes is: a pair of season passes for ReMade season 2.

b) Prizes are not transferable. No prize substitution is allowed except at the discretion of SERIAL BOX PUBLISHING. If a prize cannot be awarded due to circumstances beyond SERIAL BOX PUBLISHING 's control, a substitute prize of equal or greater retail value will be awarded.

5. NOTIFICATION OF WINNER

a) The prize winner for the Sweepstakes will be notified by email within one (1) week of the end of the Sweepstakes Period. If a potential winner cannot be contacted, is contacted and does not respond as directed within seven (7) days of attempted notification, refuses the prize, is ineligible to accept the prize or does not otherwise comply with these Official Rules, that winner's prize may be forfeited and an alternate winner may be selected. The winner must complete an affidavit of eligibility and liability and, where lawful, a publicity release. If SERIAL BOX PUBLISHING does not receive the affidavit and release from the winner within two (2) weeks of notification, that winner's prize may be forfeited and an alternate winner may be selected.

b) By accepting the prize and signing the affidavit and release, winner will be granting permission to the use of his or her name, photograph, and likeness for advertising and promotional purposes for this and similar promotions without additional compensation unless required by law. Prizes will be provided to the winner within approximately one (1) week after all required proof and documentation is received.

Use of any automated entry software is prohibited.

d) SERIAL BOX PUBLISHING makes no warranty, either express or implied, regarding this Sweepstakes, the prize, web site or any of its content, including, but not limited to, merchantability or fitness for a particular purpose.

8. ARBITRATION AND DISPUTES

As a condition of participating in the Sweepstakes, participant agrees that any and all disputes which cannot be resolved between the parties, claims and causes of action arising out of or connected with the Sweepstakes, or any prize awarded, or the determination of winner shall be resolved individually, without resort to any form of class action exclusively by arbitration pursuant to the Commercial Arbitration Rules of the American Arbitration Association, then effective and in accordance with its expedited hearing procedures. The arbitration will be conducted before a single arbitrator and will be limited solely to the dispute between participant and SERIAL BOX. The arbitrator's award, including attorneys' fees, shall be binding and may be entered as a judgment in any court of competent jurisdiction.
